THE METRO MAYORS CAUCUS (MMC), PRIMARY PROGRAM OF CIVIC RESULTS, IS A NONPARTISAN COALITION OF 38 MAYORS REPRESENTING THE SEVEN-COUNTY DENVER METROPOLITAN REGION AND MORE THAN HALF OF COLORADO'S POPULATION. MMC CONVENES LOCAL ELECTED LEADERS TO COLLABORATE ON REGIONAL ISSUES INCLUDING HOUSING, TRANSPORTATION, SUSTAINABILITY, RESILIENCY, ECONOMIC DEVELOPMENT, HOMELESSNESS, AND PUBLIC SAFETY. DURING 2025, MMC HOSTED A FULL DAY RETREAT, FIVE FULL CAUCUS MEETINGS, MULTIPLE EXECUTIVE COMMITTEE MEETINGS, POLICY BRIEFINGS, AND REGIONAL CONVENINGS THAT BROUGHT TOGETHER MAYORS, LOCAL GOVERNMENT STAFF, NONPROFIT LEADERS, BUSINESS REPRESENTATIVES, AND REGIONAL PARTNERS. GENERALLY, THERE ARE OVER 30 PEOPLE IN ATTENDANCE AT THE FULL CAUCUS MEETINGS, AND APPROXIMATELY 50 AT THE RETREAT.

THE MUNICIPAL LEADERSHIP ACADEMY (MLA) IS A STATEWIDE LEADERSHIP DEVELOPMENT PROGRAM FOR MAYORS, CITY COUNCIL MEMBERS AND TRUSTEES. THE PROGRAM PROVIDES PRACTICAL, NONPARTISAN TRAINING DESIGNED TO STRENGTHEN LOCAL GOVERNANCE AND IMPROVE LEADERSHIP CAPACITY IN COLORADO COMMUNITIES. DURING 2025, MLA CONDUCTED A MULTI-SESSION COHORT PROGRAM WITH FIFTEEN (15) PARTICIPANTS THAT INCLUDED EDUCATIONAL WORKSHOPS, FACILITATED DISCUSSIONS, SITE VISITS, AND PEER-LEARNING OPPORTUNITIES FOR LOCAL ELECTED OFFICIALS FROM MUNICIPALITIES ACROSS COLORADO. PROGRAMMING COVERED TOPICS SUCH AS GOOD GOVERNANCE, HOUSING AND LAND USE, ECONOMIC DEVELOPMENT, SUSTAINABILITY AND RESILIENCY, PUBLIC SAFETY, COMMUNICATIONS AND MEDIA RELATIONS, WATER AND ENERGY POLICY, ETHICS, AND REGIONAL COLLABORATION.
